Re: Public Information Act requests received April 11, 2007

Dear 

On April 11, 2007, the Lake Travis Independent School District ("District") received Public Information Act ("PIA") requests from you. On April 12, 2007, the District requested and received clarification in an e-mail from you regarding one of your requests, the request for "any and all documents, including but not limited to emails, between and among Lake Travis ISD and Eanes ISD since January 4, 2007 to present for any reason." In your April 12, 2007 e-mail, you stated that you were narrowing your request to:

"Communications and documents related to the following individuals:

- Any and all board members
- Superintendent and/or Superintendent's office
- Susan Bohn
- Legal representatives retained by LTISD (for example, ask David Thompson)
- Lobbyists for LTISD
- Melissa Loe"

On April 23, 2007, the District sought and received clarification from you that the District may redact e-mail addresses that are protected from disclosure under Texas Government Code from the responsive document before providing it to you.

A document responsive to your requests has been so redacted and is enclosed.

In addition, in your April 11, 2007 e-mail, you indicated that Eanes Independent School District ("Eanes ISD") had provided a copy of an e-mail sent by the District's Board President, Ms. Susan Tolles to Eanes ISD Board President, Mr. Robert Durkee, which was responsive to your January 3, 2007 request to the District. **As the District has indicated to you previously, at the time of your January 3, 2007 request, the District did not maintain a copy of the e-mail. On April 12, 2007, the District requested and obtained a copy of the e-mail from Eanes ISD, and now maintains a copy of the document. It is enclosed for your review.**
